

## Cheddify's Child Sexual Abuse and Exploitation (CSAE) Policy

At **Cheddify**, we are committed to maintaining a safe and secure online environment that prohibits any form of child sexual abuse and exploitation (CSAE). We take a zero-tolerance stance on any content, behavior, or activity that involves or promotes the abuse, exploitation, or endangerment of children. Our policy aligns with international laws and regulations, including but not limited to the U.S. PROTECT Act, COPPA, and the United Nations Convention on the Rights of the Child.

### 1. Prohibited Content and Activities

Cheddify strictly prohibits any of the following:

- **Child Sexual Abuse Material (CSAM):** Any images, videos, or media that depict the sexual exploitation or abuse of children.
- **Grooming or Exploitation:** Any attempt to befriend, manipulate, or coerce a child into sexual exploitation or other inappropriate activities.
- **Sexualization of Minors:** Content that sexualizes children, including suggestive comments, imagery, or discussions.
- **Child Trafficking or Endangerment:** Content or activities that promote or facilitate the trafficking or exploitation of minors.
- **Inappropriate Communication with Minors:** Any adult attempting to engage in inappropriate or sexually suggestive communication with minors on the platform.

### 2. Reporting and Enforcement

To ensure the protection of children, Cheddify has implemented the following measures:

- **User Reporting:** Users can report any CSAE-related content or activity through our in-app reporting tools or by contacting [safety@cheddify.com](mailto:safety@cheddify.com).
- **Human Review Team:** A dedicated team reviews all flagged content and takes immediate action as necessary.
- **Immediate Content Removal:** Any reported or detected CSAE content will be removed promptly, and responsible accounts will be permanently banned.

- **Law Enforcement Cooperation:** We work closely with law enforcement agencies and report CSAE incidents to the **National Center for Missing & Exploited Children (NCMEC)** and other relevant authorities.

### **3. User Responsibilities**

Users are expected to:

- Never post, share, or engage in any CSAE-related content.
- Report any suspected CSAE activity immediately.
- Use Cheddify responsibly and comply with all applicable laws.

Failure to comply with these responsibilities will result in immediate action, including content removal, account suspension, or legal reporting.

### **4. Prevention and Education**

Cheddify is dedicated to raising awareness and educating our community about CSAE prevention by:

- Providing safety tips and guidelines for parents and guardians.
- Partnering with child protection organizations to share resources.
- Offering educational materials to users about online safety and exploitation risks.
